Owner acknowledges that Owner has read and understands this form and understands that, in the event that Owner does not pay its water/sewer bill or any balance becomes delinquent on its water/sewer account, the Village of Burr Ridge may add collection fees, attorneys fees, costs, and any other charges permitted under The Municipal Code of Burr Ridge Sections 58.01-58.71 and 59.1.1-59.6.1.
