Residential Burglary Warrant Arrest – September 18, 2023

BURR RIDGE, IL — On September 18, 2023, Burr Ridge Investigators arrested Armani R. Harbin, 20 years of age, for a residential burglary that occurred on March 20, 2023, at a home on Cabernet Court, near Plainfield Road and County Line Road.

Burr Ridge Police allege that Harbin, and other accomplices, committed this burglary while on an early morning crime spree through Tinley Park, Mokena, Orland Park, Burr Ridge, Chicago, and Dolton, IL.

While in Burr Ridge, Harbin allegedly served as a lookout for the burglary on Cabernet Court, holding a handgun with an extended magazine. Harbin, and the others, went to two other locations in Burr Ridge, allegedly entering an unlocked vehicle to open and enter an attached residential garage, and allegedly stealing an unlocked Chevrolet Tahoe from another location.

Burr Ridge Detectives recovered the Chevrolet in Dolton, IL, and were able to assist Chicago PD in apprehending Harbin, and others, in the 10600 Block of South Oglesby. Harbin was arrested by Chicago Police at that time and charged with misdemeanor crimes and released.

Detectives continued their investigation into the events in Burr Ridge, while Orland Park PD, Tinley Park PD, Mokena PD, and Chicago PD, concurrently conducted their own investigations. On August 28, 2023, Burr Ridge Detectives secured an arrest warrant for Harbin for one count of Residential Burglary. On September 18, 2023, Harbin was picked up by Burr Ridge Detectives from the Cook County Jail, where he was being held on unrelated charges, and brought back to the Burr Ridge Police Department where he was processed then taken to the DuPage County jail to await a detention hearing. DuPage County Judge Dieden ordered Harbin detained until further order of the court.
