## CONSTRUCTION SCHEDULED TO BEGIN NEXT WEEK ON LOCAL BRIDGES OVER THE CENTRAL TRI-STATE TOLLWAY (I-294)

Extended lane closures needed through fall for bridge repairs

**DOWNERS GROVE**, **IL** – The Illinois Tollway is scheduled to begin repair work in July on four local crossroad bridges carrying traffic over the Central Tri-State Tollway (I-294) in Cook and DuPage Counties including Cermak Road, 31st Street, 47th Street, and Willow Springs Road.

Electronic message signs and construction signage will be put in place in advance to alert drivers to the start of bridge repairs and new traffic patterns.

Beginning the week of July 9, lane closures are scheduled to begin on each of the local crossroad bridges. All of the bridges will remain open during repairs with traffic shifted and reduced to one lane in each direction to safety accommodate both traffic and the work zone.

Repairs will be completed in two stages and are expected to require up to four months at each bridge. Please check the Daily Construction Alert for up-to-date closure information.

In most locations, local crossroad bridge repairs will include pavement patching, bridge deck repairs, bridge joint replacement and repairs on bridge beams, piers and girders.

In 2018, the Illinois Tollway is repairing nine local crossroad bridges including Cermak Road, 31st Street, Ogden Avenue, 47th Street, 55th Street, Willow Springs Road and 5th Avenue over I-294 and the 47th Street and 55th Street bridges over Flagg Creek.

Repair work is being coordinated with the Illinois Department of Transportation, Cook County, DuPage County, local communities, as well as local fire and police departments.

## **Work Zone Safety**

The Illinois Tollway is committed to ensuring that the Central Tri-State Tollway (I-294) and local roads remains safe for both drivers and workers during construction, which is part of the agency's overall commitment to roadway safety.

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law.

The minimum penalty for speeding in a work zone is \$375. Posted signs advise drivers of a \$10,000 fine and a 14-year jail sentence for hitting a roadway worker.

Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

## About Move Illinois

The Illinois Tollway's 15-year, \$14 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 120,000 jobs and linking economies throughout the region. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
